
Metropolitan & Rural Planning Organizations

- ✓ Funds Allocated Through the Transportation Improvement Program (TIP)





• Represent community in the project development process


> SR 3018 Whitehall Road/ University Drive Extension Widening *(integration of bike/ped facilities)*

 - Contextual issues





DVRPC – Maintenance/Resurfacing Projects






DVRPC – SR 3021 Orange St., Media Borough



SPC – SR 68 Corridor, Butler County

- Congested commuter route, multiple municipalities
- Corridor study completed
- ✓ Results fostered discussion of multimodal elements
- ✓ PE phase now underway...discussions ongoing?






York MPO – SR 624 Long Level Rd.

Lebanon MPO – North Cornwall Commons



- ✓ 5 intersections need improved
- Lebanon Valley Rail Trail adjacent to site
- Bike/ped linkages previously identified
- ✓ One intersection involved:
 - 3 municipalities School district Lebanon County DCNR PennDOT



Lebanon MPO – North Cornwall Commons





Southern Alleghenies RPO – Fike Truss Bridge

- ✓ Somerset County-owned bridge
- ✓ Initially scoped for rehabilitation
- Replacement now considered because officials emphasized importance to agriculture industry





Berks MPO – Fleetwood Borough

✓ Started as pavement restoration

✓ Now includes utility work, sidewalks, stormwater drainage, signal improvements





Berks MPO – Exeter Township

- County bridge on Township road, intersecting with state road
- Started as bridge superstructure replacement
- Now includes sidewalk relocation, bridge widening, intersection signalization

Takeaways...So Far

- ✓ Local officials appreciate face-to-face contact
- Identifying local needs that could change scope...early!
- Fostering communication among non-traditional stakeholders who then contribute to process
- Raising interest in other funding programs like Transportation Alternatives and Multimodal Transportation Fund



Lackawanna/Luzerne County MPO:

Recommendation for municipal roadmasters/public works staff to meet with PennDOT County maintenance staff annually



Takeaways...So Far

- Time/effort involved...communication and coordination is hard work!
- ✓ Do municipalities see value? What are the carrots for their involvement?
- Managing expectations of local officials/ stakeholders...can't have everything!
- Extra elements take time and add cost





Connecting Local Officials and Engineers ✓ <u>Listen</u> for community needs

- "How can we?" vs. "We can't!"
- Collaborate through all phases
- ✓ Work <u>together</u> to manage expectations
